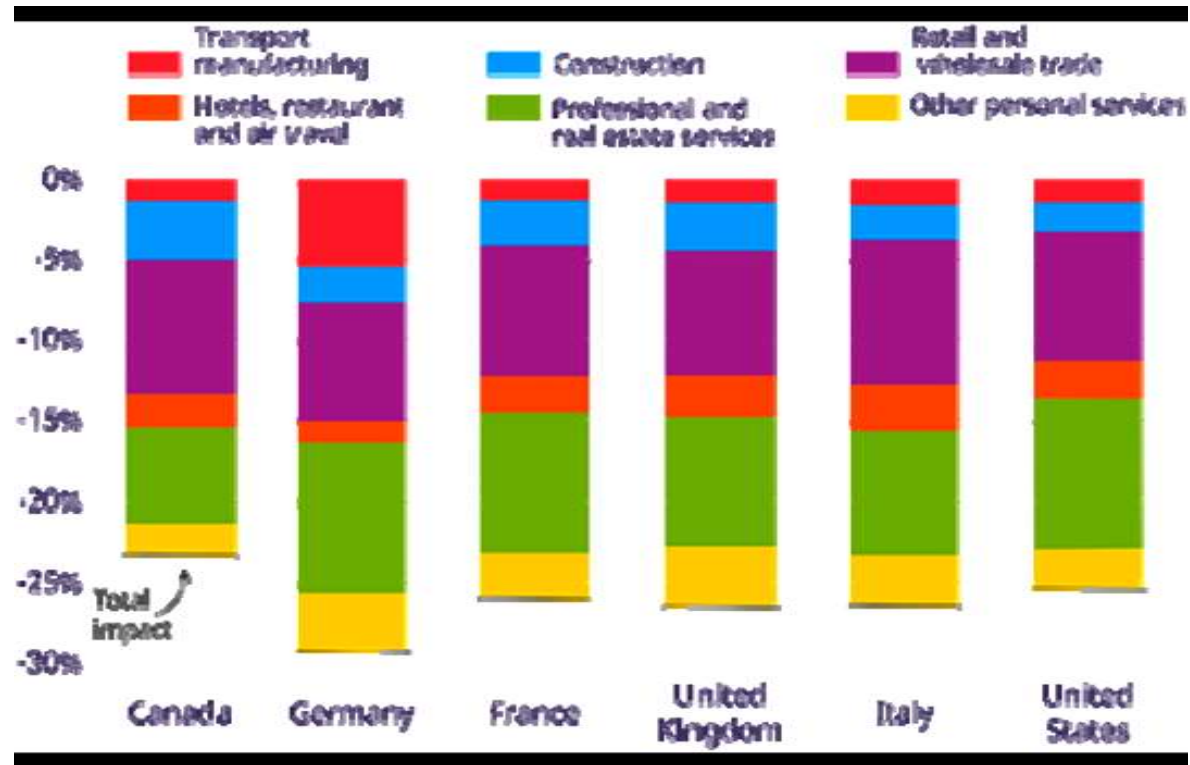
ECONOMIC IMPACT OF CORONA VIRUS
